History of the Memorial Service

In order to make recognition more appropriate and more solemn, in 2000, the Party House Leaders invited the Canadian Association of Former Parliamentarians to organize a Memorial Service to recognize all Parliamentarians who have died in the period leading up to their Annual General Meeting.
